 - Family law
 - Bankruptcy
 - Public benefit (food stamps, MA, etc)/SSI/SSDI denials
 - Areas that we cannot provide any assistance in:
 - Immigration issues
 - Criminal matters
 - Personal injury and other fee generating cases
 - Note: our funding restrictions dictate the types of cases we can take and may change over time; if you are unsure if we can assist a person just call and ask!
